Representative Matters

- **Federal Trade Commission v. Intercontinental Exchange.** Part of an all-star team of Susman Godfrey lawyers (including Kalpana Srinivasan, Shawn Raymond, and Alex Kaplan) who parachuted in to defend the \$11 billion merger of Intercontinental Exchange (“ICE”) and Black Knight. With trial imminent, the Federal Trade Commission agreed to dismiss its case and not pursue future efforts to block the merger. ICE successfully closed the transaction on September 5, 2023.
- **Brand et al. v. Promega et al.** Secured more than \$300 million — one of the largest shareholder oppression recoveries in the U.S. — for minority shareholders in Promega Corp., on claims related to control, governance, liquidity, and valuation after a month-long trial. The extremely favorable settlement occurred after the judge announced that she was “strongly leaning to find oppression here.” Promega ultimately acquired our clients’ shares for a very substantial premium over the pre-suit redemption price and the valuation Promega argued at trial. - **Ballengue v. Whiting Petroleum.** Successfully defended Whiting Petroleum Corporation against claims it tortiously interfered with a purchase and sale agreement for Bakken crude oil. The case settled on highly favorable terms following our successful depositions of plaintiff’s key witnesses.
- **Energy Industry JOA Dispute.** Won a \$19.4 million award (100% of damages sought, plus interest) in a confidential energy industry arbitration involving obligations under a joint operating agreement. The nature of the dispute and specifics about the award are confidential.
- **Energy Industry Joint Venture Dispute.** Successfully defended a publicly traded energy industry client against breach of contract and tort claims arising out of a joint venture agreement. Plaintiff’s expert had calculated approximately \$160 million in damages. We settled the case on highly favorable terms on the eve of arbitration. The settlement amount is confidential.
- **Insurance Coverage Dispute.** Recovered more than ten million dollars in settlements on behalf of publicly traded energy industry client that had been wrongfully denied coverage by its D & O carriers.
- **Patent Litigation.** Represented individual inventors and patent owners, Amit Jaipuria and Pradeep Jaipuria, in patent litigation against LinkedIn filed in a Texas federal court. The case settled for a confidential sum on the eve of trial.
- **Price Fixing (Antitrust).** Recovered tens of millions of dollars on behalf of a Fortune 100 corporation alleging price fixing by many of the world’s biggest technology manufacturers.
