

# Eight Susman Godfrey Attorneys Named ‘Leaders in their Field,’ Three Offices Ranked as Leading Firm Locations by Chambers USA

## New York Office Gains Recognition

*Chambers noted the New York office “continues to gain recognition in New York for its expertise in large commercial disputes, with notable strength in handling major class actions.” It highlighted how frequently Susman Godfrey’s New York attorneys are hired in class actions against financial institutions.*
