

# Fifty-Five Partners Named Among the Top 500 Leading Litigators in the Nation by Lawdragon – More Than Any Other Litigation Firm on the List

Fifty-five Partners from across all four of Susman Godfrey's offices have been included on *Lawdragon's* second annual list of the country's 500 Leading Litigators in America. Susman Godfrey has more lawyers on this list than any other litigation firm. In addition, **with 61% of the firm partnership included, Susman Godfrey is a rare case among the list of leading firms where more than half of the partnership is recognized.**

The 2024 list of leading litigators includes attorneys who "excel representing principally corporations and other organizations in litigating claims involving Antitrust, Securities, Financial, M&A, Intellectual Property and Patents, Product Liability, Mass Tort, White Collar, Government Investigations and Energy disputes."

Of Susman Godfrey, Lawdragon's research team says,
