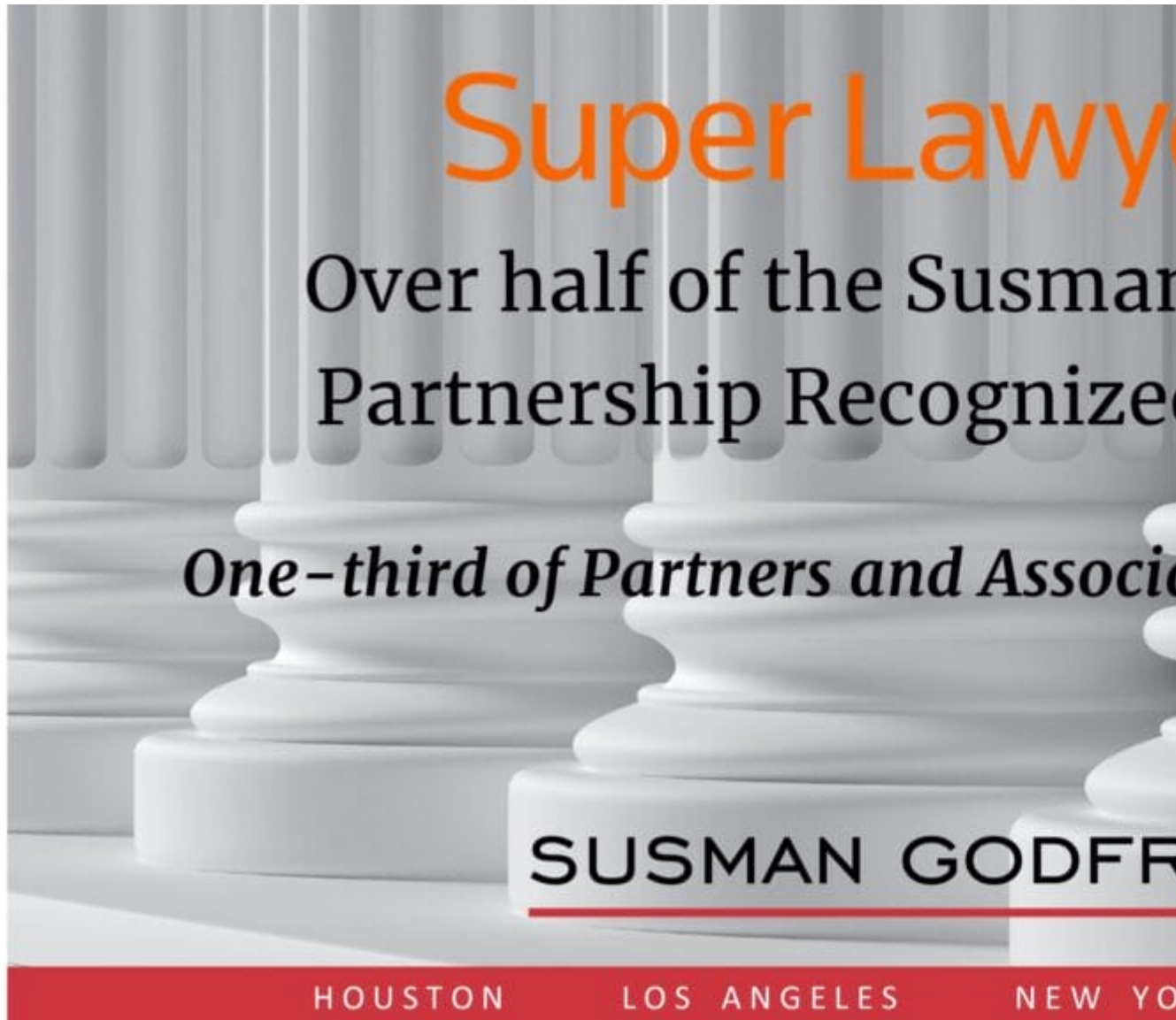


Over Half of the Susman Godfrey Partnership and One Third of its Litigators were Recognized by Super Lawyers in 2023
