The patented selection process includes independent research, peer nominations and peer evaluations. The top 5% of lawyers in a selected region are named as Super Lawyers.

The selection process for the Rising Stars list is the same as the Super Lawyers selection process, with one exception: to be eligible for inclusion in Rising Stars, a candidate must be either 40 years old or younger or in practice for 10 years or less. No more than 2.5% of the top attorneys in a selected area are named to the Rising Stars list. Super Lawyers is published by Thomson Reuters.
