

## Two Susman Godfrey Attorneys Recognized as Lawyers of the Year and 23 Others Listed in 2020 The Best Lawyers in America

Two Partners from Susman Godfrey have been named Lawyers of the Year by *The Best Lawyers in America 2020*. Barry Barnett was named the Lawyer of the Year in Houston for Patent Litigation. This is the third time since 2017 Barnett has been named a Lawyer of the Year in Houston. Seattle's Parker Folse was named Lawyer of the Year for Antitrust Litigation. This is the sixth time since 2012 that Folse was named a Lawyer of the Year in Seattle.

In all, 25 of the firm's attorneys were named among *The Best Lawyers in America 2020*. Of the group, Los Angeles Partner Steven Sklaver appears for the first time. He is recognized in Litigation: Labor and Employment in Los Angeles. In addition, firm founder Stephen Susman is recognized for the first time this year in Mass Tort Litigation / Class Actions – Plaintiffs in Houston and Partner Shawn Raymond adds Bet-the-Company Litigation to his recognitions in 2020.
