The Court further finds that Defendants in the above-captioned matter have voluntarily and knowingly waived any and all rights to appeal the entry and/or enforcement of Judgment, and have also agreed that this judgment may be entered against them without notice of presentation to them, and therefore, judgment is proper pursuant to, *inter alia*, RCW 4.60. Now, therefore,

1 IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

2 Judgment is entered against Defendants WALL TO WALL TILE & STONE, LLC, a  
3 Washington Limited Liability Company, WALL TO WALL TO WALL TILE & STONE  
4 OREGON, LLC, an Oregon limited liability company, and WALL TO WALL TILE & STONE-  
5 IDAHO, LLC, an Idaho limited liability company, in the principal sum of \$5,500,000, plus  
6 reasonable attorney's fees of \$1040.00 and costs of \$124.98 for a total of \$5,501,164.98. The  
7 judgment will accrue interest at the post-judgment rate of 18% per annum.
