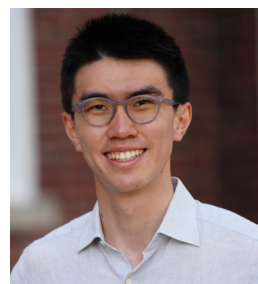
Alexis Lefft 1L, UCLA

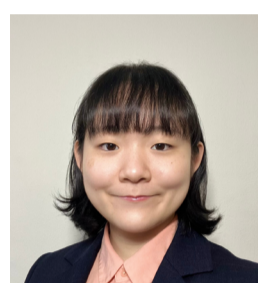
Riley Martinez 2L, Stanford
